RE: NOTIFICATION OF PRELIMINARY INJUNCTION ON TAPERED ROLLER BEARINGS FROM JAPAN (A-588-054 AND A-588-604)

1. ON 07/28/98, THE U.S. COURT OF INTERNATIONAL TRADE (THE COURT) ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO THE ANTIDUMPING FINDING ON TAPERED ROLLER BEARINGS, FOUR INCHES OR LESS IN OUTSIDE DIAMETER, AND COMPONENTS THEREOF, FROM JAPAN, CASE NUMBER A-588-054, AND PRODUCED AND/OR EXPORTED BY KOYO SEIKO, LTD. (KOYO), NTN CORPORATION (NTN), OR NSK, LTD. (NSK), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/93 THROUGH 09/30/94.

2. IN ADDITION, ON 07/28/98, THE COURT ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM JAPAN, CASE NUMBER A-588-604, AND PRODUCED AND/OR EXPORTED BY KOYO, NTN, OR NSK, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/93 THROUGH 09/30/94.

3. FINALLY, ON 07/28/98, THE COURT ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO EITHER THE A-588-054 FINDING OR THE A-588-604 ORDER AND PRODUCED AND/OR EXPORTED BY KOYO, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION, DURING THE PERIOD 10/01/92 THROUGH 09/30/93.

4. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED/EXPORTED BY KOYO, NTN, OR NSK AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/93 THROUGH 09/30/94. FURTHERMORE, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED/EXPORTED BY KOYO AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/92 THROUGH 09/30/93. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
