ON JANUARY 15, 1998 AND SEPTEMBER 8, 1998, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED PRELIMINARY INJUNCTIONS ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) FROM ITALY (A-475-201) (62 FR 54043 AND AS AMENDED AT 62 FR 61963), PRODUCED BY, EXPORTED BY, OR IMPORTED INTO THE UNITED STATES BY THE FIRMS LISTED BELOW AND ANY PARTIES RELATED THERETO DURING THE PERIOD MAY 1,

1995 THROUGH APRIL 30, 1996.

CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
