1. THE DEPARTMENT HAS COMPLETED ITS ADMINISTRATIVE REVIEWS OF THE COUNTERVAILING DUTY ORDERS ON PURE AND ALLOY MAGNESIUM FROM CANADA FOR THE 1/1/95-12/31/95 PERIOD, AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON 09/17/97.

2. IMPORTS COVERED BY THE REVIEWS ARE SHIPMENTS OF PURE AND ALLOY MAGNESIUM FROM CANADA. PURE MAGNESIUM CONTAINS AT LEAST 99.8 PERCENT MAGNESIUM BY WEIGHT AND IS SOLD IN VARIOUS SLAB AND INGOT FORMS AND SIZES. MAGNESIUM ALLOYS CONTAIN

LESS THAN 99.8 PERCENT MAGNESIUM BY WEIGHT WITH MAGNESIUM BEING THE LARGEST METALLIC ELEMENT IN THE ALLOY BY WEIGHT, AND ARE SOLD IN VARIOUS INGOT AND BILLET FORMS AND SIZES. SECONDARY AND GRANULAR MAGNESIUM ARE NOT INCLUDED IN THE SCOPE OF THE ORDERS. PURE AND ALLOY MAGNESIUM ARE CLASSIFIABLE UNDER SUBHEADINGS 8104.11.0000 AND 8104.19.0000, RESPECTIVELY, OF THE HARMONIZED TARIFF SCHEDULE.

3. ACCORDINGLY, FOR SHIPMENTS OF PURE AND ALLOY MAGNESIUM FROM CANADA, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 17, 1997, YOU SHALL COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES AT THE FOLLOWING PERCENTAGES OF THE ENTERED VALUE PRICE:
