RE: AUTOMATIC LIQUIDATION INSTRUCTIONS FOR ROASTED IN SHELL PISTACHIOS FROM IRAN (C-507-601) & CERTAIN CARBON STEEL PRODUCTS FROM SWEDEN (C-401-401)

1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDERS ON ROASTED IN-SHELL PISTACHIOS FROM IRAN (C-507-601) AND CERTAIN CARBON STEEL PRODUCTS FROM SWEDEN (C-401-401) FOR THE PERIOD 1/1/96 - 12/31/96.
2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE:

ROASTED IN-SHELL PISTACHIOS FROM IRAN (C-507-601), WHETHER ROASTED IN IRAN OR ELSEWHERE, FROM WHICH THE HULLS HAVE BEEN REMOVED, LEAVING THE INNER HARD SHELLS AND THE EDIBLE MEAT. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE (HTS) ITEM NUMBER 2008.19.30.

CERTAIN CARBON STEEL PRODUCTS FROM SWEDEN (C-401-401). THESE PRODUCTS INCLUDE SWEDISH COLD-ROLLED CARBON STEEL FLAT-ROLLED PRODUCTS, WHETHER OR NOT CORRUGATED OR CRIMPED; WHETHER OR NOT PICKLED, NOT CUT, NOT PRESSED AND NOT STAMPED TO NON-RECTANGULAR SHAPE; NOT COATED OR PLATED WITH METAL AND NOT CLAD; OVER 12 INCHES IN WIDTH AND OF ANY THICKNESS; WHETHER OR NOT IN COILS. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HTS ITEM NUMBERS 7209.11.0000, 7209.12.0000, 7209.13.0000, 7209.21.0000, 7209.22.0000, 7209.23.0000, 7209.24.5000, 7209.31.0000, 7209.32.0000, 7209.33.0000, 7209.34.0000, 7209.41.0000, 7209.43.0000, 7209.44.0000, 7209.90.0000, 7211.30.5000, 7211.41.7000, AND 7211.49.5000.

3. THEREFORE, IN ACCORDANCE WITH SECTION 351.212(C) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY SUMMARY ON THE SPECIFIED SUBJECT MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1996 AND ON OR BEFORE DECEMBER 31, 1996.

4. THE RATES OF ESTIMATED COUNTERVAILING DUTIES WHICH WERE REQUIRED TO BE DEPOSITED ARE:

5. THE ASSESSMENT OF COUNTERVAILING DUTIES BY THE CUSTOMS SERVICE ON SHIPMENTS OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE 12/31/96 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRY SUMMARIES OF THIS MERCHANDISE EXPORTED AFTER 12/31/96 WILL CONTINUE.
