ON 12/29/98, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PROFESSIONAL ELECTRICAL CUTTING TOOLS FROM JAPAN PRODUCED, MANUFACTURED OR EXPORTED BY MAKITA CORPORATION (A-588-210-001) FOR THE PERIOD 07/01/1996 THROUGH 06/30/1997.
2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED, MANUFACTURED OR

EXPORTED BY MAKITA CORPORATION AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 07/01/1996 THROUGH 06/30/1997. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
