IN ITALY BY BARILLA S.R.L. IN PACKAGES OF GREATER THAN FIVE POUNDS THAT MEET ALL THE REQUIREMENTS FOR THE MERCHANDISE SUBJECT

TO THE ANTIDUMPING DUTY ORDER, WITH THE EXCEPTION OF PACKAGING SIZE, CUSTOMS SHALL CONTINUE TO REQUIRE A CASH DEPOSIT IN THE AMOUNT EQUAL TO THE MARGIN SHOWN ABOVE FOR ONLY THOSE ENTRIES THAT ARE NOT ACCOMPANIED BY THE CERTIFICATE DESCRIBED IN PARAGRAPH 8 OF MESSAGE NUMBER 9293111.
