1. ON 03/02/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED
A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN
ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON
TAPERED ROLLER BEARINGS, AND PARTS THEREOF, FINISHED AND
UNFINISHED, FROM JAPAN, A-588-604, MANUFACTURED OR EXPORTED
BY NTN CORPORATION OR KOYO SEIKO, LTD. FOR THE PERIOD
10/01/1996 THROUGH 09/30/1997.

2. IN ADDITION, ON 03/02/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING FINDING ON TAPERED ROLLER BEARINGS, FOUR INCHES OR LESS IN OUTSIDE DIAMETER, AND COMPONENTS THEREOF, FROM JAPAN, A-588-054, MANUFACTURED OR EXPORTED BY KOYO SEIKO, LTD. FOR THE PERIOD 10/01/1996 THROUGH 09/30/1997.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY NTN CORPORATION OR KOYO SEIKO, LTD. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/1996 THROUGH 09/30/1997. CONTINUE TO SUSPEND LIQUIDATION.

OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
