RE: REVOCATION OF ANTIDUMPING DUTY ORDER ON PURE MAGNESIUM FROM UKRAINE (A-462-306)

1. THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON PURE MAGNESIUM FROM UKRAINE AND PUBLISHED THE REVOCATION

IN THE FEDERAL REGISTER ON 08/24/1999. THE EFFECTIVE DATE OF THE REVOCATION IS 10/30/1998.

2. THEREFORE, CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF PURE MAGNESIUM FROM UKRAINE ENTERED,

OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 10/30/1998.

ALL ENTRIES OF THE SUBJECT PRODUCT THAT WERE SUSPENDED ON OR AFTER 10/30/1998 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

ALL SHIPMENTS OF PURE MAGNESIUM FROM UKRAINE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BETWEEN 05/01/1998 AND 10/30/1998 SHOULD BE LIQUIDATED AT THE CASH DEPOSIT OR BONDING RATE IN EFFECT ON THE DATE OF ENTRY SUMMARY.

3. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

4.
