RE: NOTICE OF FINAL DETERMINATION IN THE ADD INVESTIGATION OF LIVE CATTLE FROM CANADA (A-122-833)

1. ON OCTOBER 21, 1999, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS FINAL DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF CATTLE FROM CANADA.
2. THE SCOPE OF THIS INVESTIGATION COVERS LIVE CATTLE FROM CANADA. FOR PURPOSES OF THIS INVESTIGATION, THE PRODUCT COVERED IS ALL LIVE CATTLE EXCEPT IMPORTS OF (1) BISON, (2) DAIRY COWS FOR THE PRODUCTION OF MILK FOR HUMAN CONSUMPTION,

AND (3) PUREBRED CATTLE AND OTHER CATTLE SPECIALLY IMPORTED FOR BREEDING PURPOSES.

THE MERCHANDISE SUBJECT TO THIS INVESTIGATION IS CLASSIFIABLE AS STATISTICAL REPORTING NUMBERS UNDER 0102.90.40 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS), WITH THE EXCEPTION OF 0102.90.40.10, 0102.90.40.72 AND 0102.90.40.74. ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE UNDER INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-122-833.

4. FOR IMPORTS OF LIVE CATTLE FROM CANADA, THE CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JULY 8, 1999 FOR ALL COMPANIES EXCEPT FOR POUND MAKER AGVENTURES, LTD., WHICH HAS A DE MINIMIS MARGIN OF 0.62 PERCENT. EFFECTIVE OCTOBER 21, 1999 CUSTOMS SHALL REQUIRE FOR ENTRIES A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS SHOWN BELOW:
