ON 09/29/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS (A-427-201) AND SPHERICAL PLAIN BEARINGS (A-427-205) FROM FRANCE, PRODUCED BY, EXPORTED TO, OR IMPORTED INTO THE UNITED STATES BY SKF USA INC., SKF FRANCE S.A., AND/OR SARMA, AND WHICH WERE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD 05/01/1997 THROUGH 04/30/1998.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED, EXPORTED TO, OR IMPORTED INTO THE UNITED STATES BY SKF USA INC., SKF FRANCE S.A. AND/OR SARMA, AND ITS SUBSIDIARIES AND AFFILIATES AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/1997 THROUGH 04/30/1998. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
