REGARDING STAINLESS STEEL WIRE ROD FROM JAPAN

1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ON SEPTEMBER 15, 1998, ITS ANTIDUMPING DUTY ORDER IN THE INVESTIGATION OF STAINLESS STEEL WIRE ROD FROM JAPAN. THIS IS A CORRECTION OF PARA 4 OF MESSAGE ADD-8259111 DATED SEPTEMBER 16, 1998.

THE DEPARTMENT OF COMMERCE FOUND THAT NO MARGINS EXIST WITH RESPECT TO HITACHI METALS, LTD. FROM JAPAN. ACCORDINGLY, HITACHI

METALS, LTD. IS EXCLUDED FROM THE ORDER AND CUSTOMS SHALL NOT SUSPEND LIQUIDATION OF STAINLESS STEEL WIRE ROD MANUFACTURED BY HITACHI METALS NOR REQUIRE A CASH DEPOSIT OR POSTING OF A BOND.

2. FOR PURPOSES OF THIS ORDER, STAINLESS STEEL WIRE ROD COMPRISES PRODUCTS THAT ARE HOT-ROLLED OR HOT-ROLLED ANNEALED AND/OR PICKLED AND/OR DESCALED ROUNDS, SQUARES, OCTAGONS, HEXAGONS OR OTHER SHAPES, IN COILS, THAT MAY ALSO BE COATED WITH A LUBRICANT CONTAINING COPPER, LIME OR OXALATE. STAINLESS STEEL WIRE ROD IS MADE OF ALLOY STEELS CONTAINING, BY WEIGHT, 1.2 PERCENT OR LESS OF CARBON AND 10.5 PERCENT OR MORE OF CHROMIUM, WITH OR WITHOUT OTHER ELEMENTS. THESE PRODUCTS ARE MANUFACTURED

ONLY BY HOT-ROLLING OR HOT-ROLLING ANNEALING, AND/OR PICKLING AND/OR DESCALING, AND ARE NORMALLY SOLD IN COILED FORM, AND ARE OF SOLID CROSS-SECTION. THE MAJORITY OF STAINLESS STEEL WIRE ROD SOLD IN THE UNITED STATES IS ROUND IN CROSS-SECTIONAL SHAPE, ANNEALED AND PICKLED, AND LATER COLD-FINISHED INTO STAINLESS STEEL WIRE OR SMALL DIAMETER BAR.

THE MOST COMMON SIZE FOR SUCH PRODUCTS IS 5.5 MILLIMETERS OR 0.217 INCHES IN DIAMETER, WHICH REPRESENTS THE SMALLEST SIZE THAT NORMALLY IS PRODUCED ON A ROLLING MILL AND IS THE SIZE THAT MOST WIRE DRAWING MACHINES ARE SET UP TO DRAW. THE RANGE OF STAINLESS STEEL WIRE ROD SIZES NORMALLY SOLD IN THE UNITED STATES IS BETWEEN 0.20 INCHES AND 1.312 INCHES IN DIAMETER. CERTAIN STAINLESS STEEL GRADES SF 20T AND K-M35FL, ARE EXCLUDED FROM THE SCOPE OF THE ORDER. THE CHEMICAL MAKEUP FOR THE EXCLUDED GRADES IS AS FOLLOWS:

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-588-843.

4. FOR IMPORTS OF STAINLESS STEEL WIRE ROD FROM JAPAN, THE CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF SUCH SHIPMENTS THAT ARE ENTERED OR WITHDRAWN FROM WAREHOUSE EXCEPT

MERCHANDISE PRODUCED AND SOLD BY HITACHI METALS LTD., AS NOTED IN PARA 1, FOR CONSUMPTION ON OR AFTER MARCH 05, 1998. EFFECTIVE SEPTEMBER 15, 1998 CUSTOMS SHALL REQUIRE FOR ENTRY SUMMARIES A CASH DEPOSIT EQUAL TO THE MARGIN SHOWN BELOW:
