1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (64 FR 66880) ON NOVEMBER 30, 1999, A NOTICE OF FINAL RESULTS OF CHANGED-CIRCUMSTANCES ANTIDUMPING AND COUNTERVAILING

DUTY ADMINISTRATIVE REVIEWS WITH RESPECT TO CERTAIN HOT-ROLLED LEAD AND BISMUTH CARBON STEEL PRODUCTS FROM THE UNITED KINGDOM. THIS NOTICE INDICATES THAT NIAGARA LASALLE (UK) LIMITED (NIAGARA) IS THE SUCCESSOR IN INTEREST TO GLYNWED METALS PROCESSING LIMITED (GLYNWED), AN EXPORTER OF CERTAIN HOT-ROLLED LEAD AND BISMUTH

CARBON STEEL PRODUCTS FROM THE UNITED KINGDOM.

2. AS GLYNWED IS EXCLUDED FROM THE COUNTERVAILING DUTY ORDER ON CERTAIN HOT-ROLLED LEAD AND BISMUTH CARBON STEEL PRODUCTS FROM THE UNITED KINGDOM, CUSTOMS SHALL LIQUIDATE ALL SHIPMENTS BY NIAGARA OF THE SUBJECT MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 21, 1999, WITHOUT REGARD TO COUNTERVAILING DUTIES.

3. WITH REGARD TO ANTIDUMPING DUTIES, A CASH DEPOSIT RATE OF 7.69 PERCENT WILL BE EFFECTIVE FOR ALL SHIPMENTS OF THE SUBJECT MERCHANDISE BY NIAGARA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER NOVEMBER 30, 1999.

4. IN ADDITION, ALL SHIPMENTS OF SUBJECT MERCHANDISE BY ANY OF THE FOLLOWING THREE ENTITIES SHALL ALSO BE SUBJECT TO THE GLYNWED RATES:

GADD DUDLEY PORT (FORMERLY KNOWN AS GEORGE GADD & COMPANY AND DUDLEY PORT ROLLING MILLS)

DUCTILE WESSON (FORMERLY KNOWN AS DUCTILE HOT MILL AND W. WESSON)

THESE THREE ENTITIES WERE FORMERLY PART OF THE GLYNWED GROUP AND ARE NOW PART OF NIAGARA.
