THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (64 FR 61581) ON 11/12/1999 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BRAKE ROTORS FROM THE PEOPLE'S REPUBLIC OF CHINA ("PRC") FOR THE PERIOD OCTOBER 10, 1996 THROUGH MARCH 31, 1998.
