1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING ORDER ON CHROME-PLATED LUG NUTS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 09/01/96 THROUGH 08/31/97 (63 FR 31719).
2. FOR SHIPMENTS OF CHROME-PLATED LUG NUTS FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 10/07/98, A CASH DEPOSIT, AS INDICATED BELOW, IS REQUIRED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

A-570-808-001 JIANGSU RUDONG GREASE GUN FACTORY:

1.23 PERCENT.

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A.IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B.IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C.WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE, OR THE MANUFACTURER IS UNKNOWN, USE THE ALL OTHER RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL OTHER PRC MANUFACTURERS/EXPORTERS OF CHROME-PLATED LUG NUTS, THE CASH DEPOSIT REQUIRED IS 44.99 PERCENT.

5 FOR NON-PRC EXPORTERS OF PRC CHROME-PLATED LUG NUTS, THE CASH DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE PRC SUPPLIER OF THAT EXPORTER.

6. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
