ON AUGUST 8, 1999, CASH DEPOSIT INSTRUCTIONS WERE ISSUED UNDER MESSAGE NUMBER 9231114 FOR DEL VERDE SRL, PASTIFICIO FABIANELLI SPA, PASTIFICIO RISCOSSA FLLI MASTROMAURO SRL, AUDISIO INDUSTRIE ALIMENTARI SPA, AND TAMMA INDUSTRIE ALIMENTARI DI CAPITANATA SRL. THESE CASH DEPOSIT RATES WERE BASED ON THE DEPARTMENT OF COMMERCE'S FINAL RESULTS OF THE ADMINISTRATIVE REVIEW OF THESE FIVE FIRMS FOR THE PERIOD 01/01/97 - 12/31/97, WHICH WERE PUBLISHED IN THE FEDERAL REGISTER ON 08/16/99 (64 FR 44489).

2. ON SEPTEMBER 22, 1999, COMMERCE PUBLISHED AMENDED FINAL RESULTS FOR FOUR OF THESE FIVE FIRMS IN THE FEDERAL REGISTER (64 FR 51293). ON THE BASIS OF THESE AMENDED RESULTS, THE CASH DEPOSIT RATES FOR THESE FOUR FIRMS HAVE BEEN REVISED. EFFECTIVE SEPTEMBER 22, 1999, CUSTOMS OFFICERS SHOULD COLLECT DEPOSITS OF COUNTERVAILING DUTIES AT THE REVISED RATES AS SHOWN BELOW. THE CASH DEPOSIT RATE FOR PASTIFICIO RISCOSSA FLLI MASTROMAURO SRL IS UNCHANGED.
