1. ON 12/30/98, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS NOTICE OF INITIATION OF ANTIDUMPING DUTY INVESTIGATIONS OF LIVE CATTLE FROM CANADA AND MEXICO, AND ITS NOTICE OF INITIATION OF A COUNTERVAILING DUTY INVESTIGATION OF LIVE CATTLE FROM CANADA.

2. FOR PURPOSES OF THESE INVESTIGATIONS, THE PRODUCT COVERED IS ALL LIVE CATTLE EXCEPT IMPORTS OF DAIRY COWS FOR THE

PRODUCTION OF MILK FOR HUMAN CONSUMPTION AND PUREBRED CATTLE
SPECIALLY IMPORTED FOR BREEDING PURPOSES AND OTHER CATTLE
SPECIALLY IMPORTED FOR BREEDING PURPOSES. THE MERCHANDISE
SUBJECT TO THESE INVESTIGATIONS IS CLASSIFIABLE AS
STATISTICAL REPORTING NUMBERS UNDER 0102.90.40 OF THE
HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS),
WITH THE EXCEPTION OF 0102.90.40.72 AND 0102.90.40.74.
