FROM INDONESIA (A-560-802)

1. ON DECEMBER 31, 1998, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS FINAL DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF CERTAIN PRESERVED MUSHROOMS FROM INDONESIA.
2. THE PRODUCTS COVERED ARE CERTAIN PRESERVED MUSHROOMS WHETHER, IMPORTED WHOLE, SLICED, DICED, OR AS STEMS AND PIECES. THE PRESERVED MUSHROOMS COVERED UNDER THIS INVESTIGATION ARE THE SPECIES AGARICUS BISPORUS AND

AGARICUS BITORQUIS. "PRESERVED MUSHROOMS" REFER TO MUSHROOMS THAT HAVE BEEN PREPARED OR PRESERVED BY CLEANING, BLANCHING, AND SOMETIMES SLICING OR CUTTING. THESE MUSHROOMS ARE THEN PACKED AND HEATED IN CONTAINERS INCLUDING BUT NOT LIMITED TO CANS OR GLASS JARS IN A SUITABLE LIQUID MEDIUM, INCLUDING BUT NOT LIMITED TO WATER, BRINE, BUTTER OR BUTTER SAUCE. PRESERVED MUSHROOMS MAY BE IMPORTED WHOLE, SLICED, DICED, OR AS STEMS AND PIECES. INCLUDED WITHIN THE SCOPE OF THE INVESTIGATION ARE "BRINED" MUSHROOMS, WHICH ARE PRESALTED AND PACKED IN A HEAVY SALT SOLUTION TO PROVISIONALLY PRESERVE THEM FOR FURTHER PROCESSING.

EXCLUDED FROM THE SCOPE OF THIS INVESTIGATION ARE THE FOLLOWING:

(1) ALL OTHER SPECIES OF MUSHROOM INCLUDING STRAW MUSHROOMS; (2) ALL FRESH AND CHILLED MUSHROOMS, INCLUDING "REFRIGERATED" OR "QUICK BLANCHED MUSHROOMS"; (3) DRIED MUSHROOMS; (4) FROZEN MUSHROOMS; AND (5) "MARINATED," "ACIDIFIED" OR " PICKLED" MUSHROOMS, WHICH ARE PREPARED OR PRESERVED BY MEANS OF VINEGAR OR ACETIC ACID, BUT MAY CONTAIN OIL OR OTHER ADDITIVES. THE MERCHANDISE SUBJECT TO THIS INVESTIGATION IS CLASSIFIABLE UNDER SUBHEADINGS 2003.10.0027, 2003.10.0031, 2003.10.0037, 2003.10.0043, 2003.10.0047, 2003.10.0053, AND 0711.90.4000 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTS"). ALTHOUGH THE HTS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE UNDER INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-560-802.
4. CLARIFICATION OF E-MAIL MESSAGE NUMBER 8218118 DATED SEPTEMBER 9, 1998, FOR CERTAIN PRESERVED MUSHROOMS FROM INDONESIA (A-560-802-). THE COMPANY LISTED AS DIENG DJAYA IS THE SAME COMPANY AS PT DIENG DJAYA (PERUSAHAAN DAGANG DAN INDUSTRI)
5. FOR IMPORTS OF CERTAIN PRESERVED MUSHROOMS FROM INDONESIA PRODUCED/EXPORTED BY PT DIENG DJAYA (PERUSAHAAN DAGAN DAN

INDUSTRI)/PT SURYA JAYA ABADI PERKASA, THE CUSTOMS SERVICE SHALL BEGIN SUSPENSION OF LIQUIDATION OF SUCH SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER DECEMBER 31, 1998. CUSTOMS SHALL REQUIRE FOR ENTRIES A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS SHOWN BELOW.

FOR IMPORTS OF CERTAIN PRESERVED MUSHROOMS FROM INDONESIA PRODUCED/EXPORTED BY PT ZETA AGRO CORPORATION, THE CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

AUGUST 5, 1998. EFFECTIVE DECEMBER 31, CUSTOMS SHALL REQUIRE FOR ENTRIES A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS SHOWN BELOW:
