THIS AMENDMENT WAS PUBLISHED ON 10/16/98 IN THE FEDERAL REGISTER (63 FR 55577) AND CHANGES THE CASH DEPOSIT RATE FOR SHANDONG MACHINERY IMPORT & EXPORT CORPORATION (SMC).
