ON 11/07/06, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN UNLIQUIDATED ENTRIES OF MIXED WAX CANDLES, WHICH ARE CANDLES CONTAINING PALM AND/OR VEGETABLE-BASED WAX AND ANY AMOUNT OF PETROLEUM WAX, WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504), PRODUCED AND EXPORTED BY QINGDAO KINKING APPLIED CHEMISTRY CO., LTD., DALIAN TALENT GIFT CO., LTD., SHANGHAI

AUTUMN LIGHT ENTERPRISE CO., LTD., AND ZHONGSHAN ZHONGNAM CANDLE MANUFACTURER CO., LTD. ON OR AFTER FEBRUARY 25, 2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00397 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF MIXED WAX CANDLES WHICH WERE PRODUCED AND EXPORTED BY QINGDAO

KINKING APPLIED CHEMISTRY CO., LTD., DALIAN TALENT GIFT CO., LTD., SHANGHAI AUTUMN LIGHT ENTERPRISE CO., LTD., AND ZHONGSHAN ZHONGNAM CANDLE MANUFACTURER CO., LTD. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER FEBRUARY 25, 2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON NOVEMBER 8, 2006. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 O'CLOCK P.M. ON THE FIFTH BUSINESS DAY AFTER NOVEMBER 8, 2006.
