PARAGRAPH 2, LINE 3, TO: CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM (A-552-801) (01/31/2003 THROUGH 07/30/2003 AND 08/11/2003 THROUGH 07/31/2004).

PARAGRAPH 3, LINE 1, TO: FOR ALL SHIPMENTS OF CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM PRODUCED/EXPORTED BY THE ABOVE FIRMS, ENTERED OR WITHDRAWN FROM

WAREHOUSE FOR CONSUMPTION DURING THE PERIOD 01/31/2003 THROUGH 07/30/2003 AND 08/11/2003 THROUGH 07/31/2004, ASSESS AN ANTIDUMPING LIABILITY EQUAL TO THE AMOUNT OF THE BOND OR CASH DEPOSIT REQUIRED AT THE TIME OF ENTRY, EXCEPT IF PARAGRAPH 4 IS APPLICABLE.

PARAGRAPH 3, TO INCLUDED AS LAST PARAGRAPH: IN ADDITION, PURSUANT TO MESSAGE 6207203 ON 07/26/2006, NONE OF THE LISTED FIRMS HEREIN ARE SUBJECT TO THE INJUNCTION INSTRUCTIONS (SEE MESSAGE 6207203 ON 07/26/2006).

PARAGRAPH 4, LINE 1, TO: IF A BOND OR CASH DEPOSIT WAS COLLECTED AS SECURITY FOR AN ESTIMATED ANTIDUMPING DUTY FOR ANY SHIPMENT OF MERCHANDISE DESCRIBED IN PARAGRAPH 2 THAT WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE

PERIOD 01/31/2003 THROUGH 07/30/2003, ASSESS A DUMPING LIABILITY EQUAL TO THE AMOUNT OF THE BOND OR CASH DEPOSIT REQUIRED AT THE TIME OF ENTRY, WHICHEVER IS LESS.
