RE: Preliminary Injunction on Lightweight Thermal Paper from Germany (A-428-840), Court Number 14-00143

1. On 06/23/2014, the U.S. Court of International Trade issued a Preliminary Injunction enjoining liquidation of certain entries of merchandise which were produced and exported by Papierfabrik August Koehler AG or Papierfabrik August Koehler SE that are subject to the antidumping duty order on lightweight thermal paper from Germany (A-428-840), and were entered, or withdrawn from warehouse, for consumption during the period 11/01/2011 through 10/31/2012.
2. This injunction was issued in connection with court case number 14-00143 and enjoins liquidation of the entries described above.
3. Liquidation instructions for entries affected by the PI have not yet been issued.
4. Accordingly, until further notice do not liquidate entries of subject merchandise which were produced and exported by Papierfabrik August Koehler AG or Papierfabrik August Koehler SE and that were entered or withdrawn from warehouse for consumption during the period 11/01/2011 through 10/31/2012. Continue to suspend liquidation of these entries until liquidation instructions are issued.
5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.
6. Commerce's APO Docket Center was served with the above-referenced injunction on 06/24/2014. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 p.m. on 06/23/2014.
