Ref: Message 4135301, dated 05/15/2014

1. Commerce has amended the final results of its administrative review of the antidumping duty order on multilayered wood flooring from the People's Republic of China for the period 05/26/2011 through 11/30/2012. This amendment was published on 06/20/2014 in the Federal Register and changes the cash deposit rate for the producers/exporters as listed in paragraph 2.
