RE: Preliminary injunction on diamond sawblades and parts thereof from the People's Republic of China for the period 11/01/2011 through 10/31/2012 (A-570-900)

1. On 08/12/2014, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on diamond sawblades and parts thereof from the People's Republic of China (A-570-900) for the period 11/01/2011 through 10/31/2012.

2. This injunction was issued in connection with court case number 14-00148 and enjoins liquidation of the entries of subject merchandise which were exported from the People's Republic of China to the United States by Beijing Gang Yan Diamond Products Co. or Cliff International Ltd. and which were entered, or withdrawn from warehouse, for consumption on or after 11/01/2011 through 10/31/2012.

Note: Although Commerce determined these two companies to be part of ATM Single Entity in the final results of this administrative review, the injunction applies only to Beijing Gang Yan Diamond Products Co. and Cliff International Ltd.

3. Accordingly, until further notice, do not liquidate entries of subject merchandise which (1) were entered, or withdrawn from warehouse, for consumption on or after 11/01/2011 through 10/31/2012; (2) were the subject of the administrative proceeding published as Diamond Sawblades From the People's Republic of China: Final Results of Antidumping Duty Administrative Review; 2011-2012, 79 Fed. Reg. 35723 (Dep't Commerce June 24, 2014); (3) were exported from the People's Republic of China to the United States by Beijing Gang Yan Diamond Products Co. or Cliff International Ltd.; and (4) remain unliquidated as of 5:00 p.m. on 08/19/2014, the fifth business day after the date on which the U.S. Court of International Trade issues the preliminary injunction order. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Liquidation instructions for entries affected by the injunction have not yet been issued.

5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.
6. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 p.m. on 08/19/2014, the fifth business day after the date on which the U.S. Court of International Trade issued the preliminary injunction order.
