RE: TRO on diamond sawblades from Korea for plaintiffs Hyosung Diamond Industrial Co., Ltd., Western Diamond Tools Inc., or Hyosung D&P Co., Ltd. period 1/24/09 through 10/23/2011, A580855, ct no 06-00248

1. On 08/27/2014, the U.S. Court of International Trade issued a temporary restraining order (TRO) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on diamond sawblades from the Republic of Korea (A-580-855) for the periods 01/24/2009 through 10/31/2010 or 11/01/2010 through 10/23/2011. This TRO was issued in connection with court number 06-00248.

2. The TRO and PI both enjoin liquidation of entries which:

1. were entered, or withdrawn from warehouse, for consumption for the period January 24, 2009 through October 31, 2010 or for the period November 1, 2010 through October 23, 2011;

2. were ordered by the Department of Commerce to be liquidated by U.S. Customs and Border Protection pursuant to Message No. 4162301 dated June 11, 2014 and Message No. 4175304 dated June 24, 2014;

3. were exported from the Republic of Korea to the United States by Hyosung D&P Co., Ltd; and

4. remain unliquidated as of 5 p.m. on this date on which the Court issues the order granting Hyosung's Motion for Temporary Restraining Order.

3. Effective 08/27/2014, no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated as of 5pm 08/27/2014. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Effective immediately, CBP is instructed to follow the terms of the TRO.
