1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (77 FR 52683) ON 08/30/2012 THE IMPLEMENTATION OF ITS SECTION 129 DETERMINATION REGARDING THE ANTIDUMPING DUTY ORDER ON LAMINATED WOVEN SACKS FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 10/06/2006 THROUGH 03/31/2007. THE EFFECTIVE DATE OF THIS DETERMINATION IS 08/21/2012.

2. AS A RESULT OF COMMERCE'S DETERMINATION, THE ANTIDUMPING CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN COMPANIES. THEREFORE, FOR SHIPMENTS OF LAMINATED WOVEN SACKS FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/21/2012, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED AS LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE EXPORTERS LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE PRC OR NON-PRC EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE TO DETERMINE THE CASH DEPOSIT RATE.

B. FOR ALL PRC EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT BEEN ASSIGNED A SEPARATE RATE, THE CASH DEPOSIT RATE WILL BE THE PRC-WIDE RATE OF 47.64 PERCENT.

C. FOR ALL NON-PRC EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT RECEIVED THEIR OWN RATE, THE CASH DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE PRC EXPORTER THAT SUPPLIED THAT NON-PRC EXPORTER.

4. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE.
