RE: Correction of message 4281302, dated 10/08/2014 concerning the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam (A-552-802)

1. This is a correction to message 4281302, dated 10/08/2014, to correct paragraph 2.
2. Paragraph 2 of message 4281302 contains incorrect information about certain trade names used for several exporters. Commerce has amended the final results of its administrative review of the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam for the period 02/01/2012 through 01/31/2013. This amendment was published on 11/04/2014 in the Federal Register (79 FR 65377) and corrected the trade names used for certain exporters as listed in paragraph 4. Below is the fully corrected message.
3. Commerce has published in the Federal Register (79 FR 57047) on 09/24/2014 the final results of administrative review of certain exporters subject to the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam ("Vietnam") for the period 02/01/2012 through 1/31/2013.
4. As a result of Commerce's review, the cash deposit rates have been revised for certain exporters. Therefore, for shipments of certain frozen warmwater shrimp from Vietnam entered, or withdrawn from warehouse, for consumption on or after 09/24/2014, the required cash deposit has been revised for the following exporters:

B. For all Vietnam exporters of subject merchandise which have not been assigned to a separate rate, the cash deposit rate will be the Vietnam-wide rate of 25.76 percent.

C. For all non-Vietnam exporters of subject merchandise which have not received their own rate,

the cash deposit rate will be the rate applicable to the Vietnam exporter that supplied that non-Vietnam exporter.

6. These cash deposit requirements shall remain in effect until further notice. Do not liquidate any entries of merchandise included in this administrative review until assessment instructions are issued.
