RE: Notification of rescission of new shipper review of antidumping duty order on certain frozen fish fillets from the Socialist Republic of Vietnam (A-552-801).

1. On 12/05/2014, the Department of Commerce published in the Federal Register (79 FR 72170) the rescission of the new shipper review of the antidumping duty order on certain frozen fish fillets from the Socialist Republic of Vietnam produced and exported by BASA JOINT STOCK COMPANY (A-552-801-068) covering the period 08/01/2013 through 07/31/2014.

2. As a result of Commerce's rescission of this new shipper review, the option of a bond in lieu of a cash deposit is no longer permitted. For shipments of subject merchandise produced and exported by BASA JOINT STOCK COMPANY which were entered, or withdrawn from warehouse, for consumption on or after 12/05/2014, cash deposits only should be collected at the Vietnam-wide rate in effect on date of entry. The Vietnam-wide rate currently in effect is \$2.11/kg. Additionally, as a result of Commerce's rescission of this new shipper review, shipments of subject merchandise produced and exported by BASA JOINT STOCK COMPANY may no longer enter under case number A-552-801-068, effective the date of publication of the rescission in the Federal Register. Such merchandise should now be entered under case number A-552-801-000 until such time as the exporter receives its own rate.

3. Do not liquidate any entries covered by this review until you have received liquidation instructions.
