RE: Injunction on hand trucks and certain parts thereof from People's Republic of China for 12/01/2009 thru 11/30/2010 for New-Tec Integration (Xiamen) Co.,Ltd.(A-570-891),court number 12-000243

1. On 08/20/2012, the U.S. Court of International Trade issued an injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on hand trucks and certain parts thereof from the People's Republic of China (A-570-891) for the period 12/01/2009 through 11/30/2010.
2. This injunction was issued in connection with court case number 12-000243 and enjoins liquidation of the entries described in paragraph 3 below.
3. Accordingly, until further notice, do not liquidate entries of subject merchandise which were the subject of the administrative determination published as Hand Trucks and Certain Parts Thereof From the People's Republic of China, 77 Fed. Reg. 41,744 (Dep't Commerce July 16, 2012); were produced and exported from the People's Republic of China to the United States by New-Tec Integration (Xiamen) Co., Ltd.; and were entered, or withdrawn from warehouse, for consumption during the period 12/01/2009 through 11/30/2010. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Liquidation instructions for entries affected by the injunction have not yet been issued.
5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.
6. Commerce's APO Docket Center was served with the above-referenced injunction on 08/21/2012. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 pm on 08/20/2012.
