RE: Temporary restraining order on honey from the People's Republic of China for various companies for the period of 05/11/2001 through 02/05/2015 (A-570-863), court number 02-00064

1. On 02/05/2015, the U.S. Court of International Trade issued a temporary restraining order (TRO) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on honey from the People's Republic of China (A-570-863) for the period 05/11/2001 through 02/05/2015. This TRO was issued in connection with court number 02-00064.
2. This TRO enjoins liquidation of entries which (1) were subject to the administrative determination published as Notice of Amended Final Determination of Sales at Less Than Fair Value and Antidumping Duty Order; Honey From the People's Republic of China, 66 Fed. Reg. 63,670 (Dec. 10, 2001); (2) were produced, exported, or imported from the People's Republic of China by Zhejiang Native Produce & Animal By-Products Import & Export Corp., Kunshan Foreign Trade Co., China (Tushu) Super Food Import & Export Corp., High Hope International Group Jiangsu Foodstuffs Import & Export Corp., National Honey Packers & Dealers Association, Alfred L. Wolff, Inc., C.M. Goettsche & Co., China Products North America, Inc., D.F. International (USA) Inc., Evergreen Coyle Group Inc., Evergreen Produce Inc., Pure Sweet Honey Farm Inc., and Sunland International Inc.; and (3) were entered, or withdrawn from warehouse, for consumption during the period of 5/11/2001 through 2/05/2015, the date upon which the order was docketed.
3. Effective 02/05/2015 (the date the Court issued the TRO), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated from the date hereof until 5:00 p.m. on the fifth business day after the day on which defendant-intervenors have filed their response to plaintiffs' motion for preliminary injunction.
4. Effective immediately, CBP is instructed to follow the terms of the TRO.
5. Liquidation instructions for entries affected by this TRO have not yet been issued.
