RE: Amended cash deposit instructions for wooden bedroom furniture from the People's Republic of China (A-570-890).

1. Commerce has amended the final results of its administrative review of the antidumping duty order on wooden bedroom furniture from the People's Republic of China for the period 1/1/2008 through 12/31/2008. This amendment was published on 1/29/2015 in the Federal Register (80 FR 4870) and changes the cash deposit rate for the exporters as listed in paragraph 2.

2. For shipments of wooden bedroom furniture from the People's Republic of China entered, or withdrawn from warehouse, for consumption on or after 8/18/2010, the amended cash deposit requirement is as follows:
