RE: Preliminary injunction on certain frozen fish fillets from the Socialist Republic of Vietnam for the period 08/01/2012 through 07/31/2013 (A-552-801), court number 15-00044

1. On 03/19/2015, the U.S. Court of International Trade (CIT) issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on certain frozen fish fillets from the Socialist Republic of Vietnam (A-552-801) for the period 08/01/2012 through 07/31/2013. This PI was issued in connection with court number 15-00044.
2. This PI enjoins liquidation of entries which were entered, or withdrawn from warehouse, for consumption between 08/01/2012 through 07/31/2013, and were exported by the following entities: An Giang Fisheries Import and Export Joint Stock Company; Asia Commerce Fisheries Joint Stock Company; Cuu Long Fish Joint Stock Company; Hiep Thanh Seafood Joint Stock Company; International Development and Investment Corporation; NTSF Seafoods Joint Stock Company; Thuan An Production Trading and Services Co., Ltd.; and Vinh Quang Fisheries Joint-Stock Company.
3. Effective 03/19/2015 (the date the CIT issued the PI), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated as of 5pm on 03/19/2015. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Effective immediately, CBP is instructed to follow the terms of the PI.
5. The PI applies to the liquidation instructions in message number 5034302, dated 02/03/2015, as corrected in message number 5043303, dated 02/12/2015.
6.
