RE: Preliminary injunction on chlorinated isocyanurates from the People's Republic of China for Heze Huayi Chemical Co., Ltd. for the period 06/01/2012 through 05/31/2013 (A-570-898), court # 15-00027

1. On 02/11/2015, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on chlorinated isocyanurates from the People's Republic of China (A-570-898) for the period 06/01/2012 through 5/31/2013. This PI was issued in connection with court number 15-00027.

2. This PI enjoins liquidation of entries of chlorinated isocyanurates from the People's Republic of China (Case No. A-570-898) that were entered, or withdrawn from warehouse, for consumption on or after 06/01/2012 through 05/31/2013; were the subject of the administrative proceeding published as Chlorinated Isocyanurates From the People's Republic of China: Final Results of Antidumping Duty Administrative Review; 2012-2013, 80 Fed. Reg. 4539 (Dep't Commerce Jan. 28, 2014); and were produced by Heze Huayi and exported by Heze Huayi from the People's Republic of China to the United States.

Note: The court order used an abbreviated name for the company and an incorrect date when citing the Federal Register. We are in the process of having the court order amended to reflect the full name Heze Huayi Chemical Co., Ltd., for the company and the correct date of Jan 28, 2015, for the Federal Register cite.

3. Effective 02/11/2015 (the date the Court issued the PI), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Effective immediately, CBP is instructed to follow the terms of the PI.

5. Liquidation instructions for entries affected by this PI have not yet been issued.
