RE: Preliminary injunction on chlorinated isocyanurates from the PRC for Heze Huayi Chemical Co., Ltd. (Heze Huayi) for the period 06/01/2012 through 05/31/2013 (A-570-898), ct. no. 15-00027

1. On 02/11/2015, the U.S. Court of International Trade (CIT) issued a preliminary injunction (PI) with court number 15-00027 enjoining liquidation of entries subject to the antidumping duty order on chlorinated isocyanurates from the People's Republic of China (A-570-898) for the period 06/01/2012 through 5/31/2013. See message 5079306, dated 03/20/2015. On 03/27/2015, the CIT issued an amended PI in connection with court number 15-00027 to correct a typo in the Federal Register cite. This message amends message 5079306, dated 03/20/2015.

2. The amended PI enjoins liquidation of entries of chlorinated isocyanurates from the People's Republic of China (A-570-898) that were entered, or withdrawn from warehouse, for consumption on or after 06/01/2012 through 05/31/2013; were the subject of the administrative proceeding published as Chlorinated Isocyanurates From the People's Republic of China: Final Results of Antidumping Duty Administrative Review; 2012-2013, 80 FR 4539, dated 1/28/2015; and were produced by Heze Huayi and exported by Heze Huayi from the People's Republic of China to the United States.

Note: Despite the note in paragraph 2 of message 5079306, the court order was not corrected for the company's name since the full name was used; i.e., the name was first stated in full as Heze Huayi Chemical Co., Ltd., then later abbreviated as Heze Huayi.

3. Effective 03/27/2015 (the date the CIT issued the amended PI), no liquidation may be made for entries referred to in paragraph 2 above which remain unliquidated. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Effective immediately, CBP is instructed to follow the terms of the PI.

5. Liquidation instructions for entries affected by this PI have not yet been issued.
