RE: Notice of preliminary determination in the countervailing duty investigation of drawn stainless steel sinks from the People's Republic of China (C-570-984)

1. On 08/06/2012, Commerce published in the Federal Register its affirmative preliminary determination in the countervailing duty investigation of drawn stainless steel sinks from the People's Republic of China (77 FR 46717).
2. The products covered by this investigation are described in message 2101302 dated 04/10/2012 and message 2115302 dated 04/24/2012.
3. This investigation has been assigned investigation number C-570-984.
4. For imports of drawn stainless steel sinks from the People's Republic of China, CBP shall suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 08/06/2012. Effective 08/06/2012, CBP shall require for such entries, a cash deposit equal to the rates listed in the appended company-upload table for merchandise produced by Zhongshan Superte Kitchenware Co., Ltd. and exported by Foshan Zhaoshun Trade Co., Ltd. (-003) in this combination only. For shipments of subject merchandise from the exporter identified above in any other combination, a cash deposit should be collected at the countrywide rate in effect on the date of entry. For the other entities listed in the appended company-upload table, CBP shall collect a cash deposit equal to the listed rates for which merchandise was produced and/or exported by such companies, i.e., (-001 and -002). CBP should refer to the Notes tab in the ACE case reference file for any company affiliations. The countrywide rate currently in effect is 8.03 percent.
