RE: Notification of rescission of new shipper review of antidumping duty order on freshwater crawfish tail meat from the People's Republic of China (A-570-848)

1. On 04/29/2015, the Department of Commerce published in the Federal Register (80 FR 23771) the rescission of the new shipper review of the antidumping duty order on freshwater crawfish tail meat from the People's Republic of China produced and exported by Wuhan Coland Aquatic Products and Food Co., Ltd. (A-570-848-060) covering the period 09/01/2013 through 08/31/2014.
2. As a result of Commerce's rescission of this new shipper review, the option of a bond in lieu of a cash deposit is no longer permitted. For shipments of subject merchandise produced and exported by Wuhan Coland Aquatic Products and Food Co., Ltd. which were entered, or withdrawn from warehouse, for consumption on or after 04/29/2015, cash deposits only should be collected at the PRC-wide rate in effect on date of entry. The PRC-wide rate currently in effect is 223.01 percent. Additionally, as a result of Commerce's rescission of this new shipper review, shipments of subject merchandise produced and exported by Wuhan Coland Aquatic Products and Food Co., Ltd. may no longer enter under case number A-570-848-060, effective the date of publication of the rescission in the Federal Register. Such merchandise should now be entered under case number A-570-848-000 until such time as the exporter receives its own rate.
3. Do not liquidate any entries covered by this review until you have received liquidation instructions.
4.
