RE: Antidumping duty scope determination on magnesium metal from the People's Republic of China (A-570-896).

Notice of the lifting of suspension occurred on the message date of these instructions. See paragraph 5 below.

1. Commerce received a scope ruling request from Dead Sea Magnesium Ltd. Commerce issued a final scope determination on 07/16/2015 that Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys which Dead Sea Magnesium Ltd. imports are not within the scope of the antidumping duty order on magnesium metal from the People's Republic of China (A-570-896).

2. Commerce determined that Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys MRI 153M and MRI 230D are outside the scope of the order because they do not conform to ASTM standards. Therefore, Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys MRI 153M and MRI 230D are not within the scope of the antidumping duty order on magnesium metal from the People's Republic of China.

3. For all entries of Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys that remain unliquidated on or after 10/04/2004, CBP shall terminate suspension and liquidate entries of product not within scope which were entered, or withdrawn from warehouse, for consumption.

4. Refund any cash deposits relating to Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys described above.

5. These instructions constitute notice of the lifting of suspension of liquidation of entries of Dead Sea Magnesium Ltd.'s proprietary, patented magnesium alloys entered, or withdrawn from warehouse, for consumption on or after 10/04/2004.

6. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not

applicable to cash or bonds posted as estimated antidumping duties before the date of publication of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

7. Unless instructed otherwise, for all other shipments of magnesium metal from the People's Republic of China not covered by paragraph 2 above, you shall continue to collect cash deposits of estimated antidumping duties for the merchandise at the current rates.
