RE: Preliminary injunction on Multilayered Wood Flooring from China for Yingyi-Nature (Kunshan) Wood Industry Co. Ltd. for the period 12/01/2012 through 11/30/2013 (A-570-970), Court # 15-00204

1. On 07/29/2015, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on Multilayered Wood Flooring from PRC (A-570-970) for the period 12/01/2012 through 11/30/2013. This PI was issued in connection with court number 15-00204.
2. This PI enjoins liquidation of entries which were entered, or withdrawn from warehouse, for consumption on or after December 1, 2012 until November 30, 2013; were the subject of the administrative proceeding published as Multilayered Wood Flooring From the People's Republic of China: Final Results of Antidumping Duty Administrative Review and Final Results of New Shipper Review; 2012-2013, 80 Fed. Reg. 41,476 (July 15, 2015); were exported from the People's Republic of China to the United States by Yingyi-Nature (Kunshan) Wood Industry Co., Ltd.; and remain unliquidated as of 5 p.m. on 07/29/2015.
3. Effective 07/29/2015 (the date the Court issued the PI), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated as of 5 p.m. on 07/29/2015. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Effective immediately, CBP is instructed to follow the terms of the PI.
5. Liquidation instructions for entries affected by this PI have not yet been issued.
