RE: Preliminary injunction on diamond sawblades and parts thereof from the PRC for AT&M entity and/or any of its members, pertaining to entries on or after 03/22/2013 (A-570-900), court no. 13-00168

1. On 08/20/2015, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 3 which are subject to the antidumping duty order on diamond sawblades and parts thereof from the People's Republic of China (A-570-900) for certain entries that were or are made on or after 03/22/2013. This PI was issued in connection with court number 13-00168.

2. The temporary restraining order implemented in message number 5180303, dated 06/29/2015, is dissolved effective 08/20/2015.

3. This PI enjoins liquidation of unliquidated entries of diamond sawblades and parts thereof from the People's Republic of China that are subject to Certain Frozen Warmwater Shrimp from the People's Republic of China and Diamond Sawblades and Parts Thereof from the People's Republic of China (78 FR 18958, 03/28/2013) (notice of implementation of determinations under Section 129 of the Uruguay Round Agreements Act and partial revocation of the antidumping duty orders) produced and/or exported by the AT&M entity and/or any of its members, to the extent that such entries were or are made on or after 03/22/2013. In this context, the term entries means merchandise entered, or withdrawn from warehouse, for consumption on or after 03/22/2013.

The members of the AT&M entity subject to this PI are Advanced Technology & Materials Co., Ltd.; Beijing Gang Yan Diamond Products Co. (a/k/a Beijing Gang Yan Diamond Products Co., Ltd., Beijing Gang Yan Diamond Products Company); HXF Saw Co., Ltd. (a/k/a Yichang HXF Circular Saw Industrial Co., Ltd.); AT&M International Trading Co., Ltd. (a/k/a ATM International Trading Co., Ltd.); and Cliff International Ltd. (a/k/a Cliff (Tianjin) International Ltd., Cliff (Tianjin) International Ltd., Company).

4. Effective 08/20/2015, no liquidation may be made for unliquidated entries referred to in paragraph 3. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

5. Effective immediately, CBP is instructed to follow the terms of the PI.
6. Liquidation instructions for entries affected by this PI have not yet been issued.
