RE: Correction of message 5239308, dated 08/27/2015 concerning the antidumping duty order on multilayered wood flooring from the People's Republic of China (A-570-970).

1. This is a correction to message 5239308, dated 08/27/2015, to correct the message subtype in the header of that message.

2. The header of message 5239308 contains an incorrect message subtype. The message subtype in message 5239308 was incorrectly listed as "TRO-Temp Rest Order". Instead, the message subtype should be "PRELIM-Preliminary". The body of the message remains unchanged and is contained below for your convenience.

3. On 08/24/2015, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 4 which are subject to the antidumping duty order on multilayered wood flooring from the People's Republic of China (A -570-970) for the period 12/01/2012 through 11/30/2013. This PI was issued in connection with court number 15-00227.

4. This PI enjoins liquidation of entries which were entered, or withdrawn from warehouse, for consumption on or after December 1, 2012 until November 30, 2013; were the subject of the administrative proceeding published as Multilayered Wood Flooring From the People's Republic of China: Final Results of Antidumping Duty Administrative Review and Final Results of New Shipper Review; 2012-2013, 80 Fed. Reg. 41,476 (July 15, 2015); were exported from the People's Republic of China to the United States by Linyi Bonn Flooring Manufacturing Co., Ltd.; and remain unliquidated as of 5 p.m. on 8/24/2015.

5. Effective 08/24/2015 (the date the Court issued the PI), no liquidation may be made for entries referred to in paragraph 4 which remain unliquidated as of 5pm on 8/24/2015. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

6. Effective immediately, CBP is instructed to follow the terms of the PI.

7. The PI applies to the liquidation instructions in message number 5218312, dated 08/06/2015.
