RE: Correction of message 5219301, dated 08/07/2015, concerning the antidumping duty order on multilayered wood flooring from the PRC (A-570-970).

1. This is a correction to message 5219301, dated 08/07/2015, to correct paragraph 1 of that message.
2. Paragraph 1 of message 5219301 did not contain an exhaustive list of case numbers under which the enumerated firms' subject merchandise may have been entered. Additionally, we are updating that message to reflect three new injunctions that have been filed following our issuance of message 5219301. Below is the fully corrected message.
3. For all shipments of multilayered wood flooring from the People's Republic of China ("PRC") exported by the firms listed below and entered, or withdrawn from warehouse, for consumption during the period 12/01/2012 through 11/30/2013, assess an antidumping liability equal to 13.74 percent of the entered value of subject merchandise:

The notice of the lifting of suspension of liquidation for entries of subject merchandise covered by paragraph 3 occurred with the publication of the final results of the administrative review (80 FR 41476, 07/15/2015). Unless instructed otherwise, for all other shipments of multilayered wood flooring from the PRC, you shall continue to collect cash deposits of estimated antidumping duties for the merchandise at the current cash deposit rates or per-unit amounts.

5a. The injunction in connection with court number 12-00020, identified in message number 4142301, dated 05/22/2014, is applicable to the entries exported by Fine Furniture (Shanghai) Limited on or after 05/26/2011. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

5b. The injunction in connection with court number 15-00210, identified in message number 5231304, dated 08/19/2015, is applicable to the entries exported by Fine Furniture (Shanghai) Limited or Double F Limited during the period 12/01/2012 through 11/30/2013. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

5c. The injunction in connection with court number 15-00204, identified in message number 5217302, dated 08/05/2015, is applicable to the entries exported by Dun Hua City Jisen Wood Industry Co., Ltd. during the period 12/01/2012 through 11/30/2013. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

5d. The injunction in connection with court number 15-00204, identified in message number 5217301, dated 08/05/2015, is applicable to the entries exported by Yingyi-Nature (Kunshan) Wood Industry Co., Ltd. during the period 12/01/2012 through 11/30/2013. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

5e. The injunction in connection with court number 15-00225, identified in message number 5229301, dated 08/17/2015, is applicable to the entries exported by Baishan Huafeng Wooden Product Co., Ltd. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

5f. The injunction in connection with court number 15-00234, identified in message number 5236304, dated 08/24/2015, is applicable to the entries exported by Armstrong Wood Products (Kunshan) Co. Ltd. during the period 12/01/2012 through 11/30/2013. Accordingly, until further notice, continue to suspend liquidation of these entries until liquidation instructions are issued.

6. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not applicable to cash or bonds posted as estimated antidumping duties before the date of publication of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such

period.

7. Upon assessment of antidumping duties, CBP shall require that the importer provide a reimbursement statement, as described in section 351.402(f)(2) of Commerce's regulations. The importer should provide the reimbursement statement prior to liquidation of the entry. If the importer certifies that it has an agreement with the producer, seller, or exporter, to be reimbursed antidumping and/or countervailing duties, CBP shall double the antidumping duty and/or increase the antidumping duty by the amount of the countervailing duties in accordance with the above-referenced regulation. Additionally, if the importer does not provide the reimbursement statement prior to liquidation, reimbursement shall be presumed and CBP shall double the antidumping duties due. If an importer timely files a protest challenging the presumption of reimbursement and doubling of duties, consistent with CBP's protest process, CBP may accept the reimbursement statement filed with the protest to rebut the presumption of reimbursement.
