RE: Cash deposit instructions for citric acid and certain citrate salts from Canada (A-122-853)

1. Commerce has published in the Federal Register (80 FR 62016) on 10/15/2015 the final results of its administrative review of certain producers and/or exporters subject to the antidumping order on citric acid and certain citrate salts from Canada for the period 05/01/2013 through 04/30/2014.
2. As a result of Commerce's review, the cash deposit rate has been revised for the company listed below. Therefore, for shipments of citric acid and certain citrate salts from Canada produced and/or exported by the firm listed below, entered, or withdrawn from warehouse, for consumption on or after 10/15/2015, the required cash deposit has been revised:

Producer and/or Exporter: Jungbunzlauer Canada Inc.

Case number: A-122-853-001

Cash deposit rate: 0.00%

3. If any entries of merchandise are exported by a firm other than the producer, then the following instructions apply:
  - A. If the exporter of the subject merchandise has its own rate, use the exporter's rate to determine the cash deposit rate.
  - B. If the exporter of the subject merchandise does not have its own rate, but the producer has its own rate, the cash deposit rate will be the producer's rate.
  - C. Where neither the exporter nor the producer currently has its own rate or the producer is unknown, use the all-others rate for establishing the cash deposit rate.
4. For all producers/exporters of citric acid and certain citrate salts from Canada without their own rate, the cash deposit rate is 23.21 percent.
5. These cash deposit requirements shall remain in effect until further notice. Do not liquidate any entries of merchandise covered by the administrative review until specific liquidation instructions

are issued.
