RE: Temporary restraining order and preliminary injunction on certain frozen warmwater shrimp from India for the period 02/01/2013 through 01/31/2014 (A-533-840), court number 15-00282

1. On 10/16/2015, the U.S. Court of International Trade issued a temporary restraining order (TRO) and a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on frozen warmwater shrimp from India (A-533-840) for the period 02/01/2013 through 01/31/2014. These documents were issued in connection with court number 15-00282.

2. The TRO and PI both enjoin liquidation of entries which are subject to the administrative determination in Certain Frozen Warmwater Shrimp from India: Final Results of Antidumping Duty Administrative Review, 2013-2014, 80 FR 54524 (Sept. 10, 2015), entered or withdrawn from warehouse, for consumption, during the period 02/01/2013 through 01/31/2014, inclusive, and produced and/or exported by the firms listed below:

Effective 10/16/2015 (the date the Court issued the TRO), no liquidation of the entries referred to in paragraph 2 may be made for entries which remain unliquidated as of 10/16/2015 through 5 p.m. on 10/23/2015. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Pursuant to the terms of the PI, no liquidation of the entries referred to in paragraph 2 may be made for entries which remain unliquidated as of 5 p.m. on 10/23/2015.

5. Effective immediately, CBP is instructed to follow the terms of the TRO and PI.
6. The TRO and PI apply to the liquidation instructions in message numbers 5271303, 5271304, and 5271305, dated 09/28/2015.
