RE: Notice of an amended final determination in the AD investigation of welded line pipe from the Republic of Korea (A-580-876)

1. Commerce has amended the final determination in the antidumping duty investigation on welded line pipe from the Republic of Korea (Korea). This amendment was published on 11/10/2015 in the Federal Register (80 FR 69637) and changes the cash deposit rate for certain producers and/or exporters.

2. The products covered by this investigation are described in message 4321308, dated 11/17/2014.

3. For shipments of welded line pipe from Korea entered, or withdrawn from warehouse, for consumption on or after 11/10/2015, CBP shall require, for such entries, a cash deposit equal to the margin for the producer and/or exporter listed below:

Producer and/or Exporter: Hyundai HYSCO (aka Hyundai Steel Company*)

Case Number: A-580-876-001

Cash Deposit Rate: 6.23%

*Note: Effective 07/01/2015, Hyundai HYSCO merged with Hyundai Steel Company, and the merged entity operates under the name Hyundai Steel Company. Accordingly, the above-stated case number applies to Hyundai Steel Company effective 07/01/2015. Entries from this company may have continued to enter under the old name, Hyundai HYSCO, after 07/01/2015.
