RE: Amended cash deposit instructions for circular welded carbon steel pipes and tubes from Turkey (C-489-502)

Commerce has amended the final results of its administrative review of the countervailing duty order on circular welded carbon steel pipes and tubes from Turkey for the period 01/01/2013 through 12/31/2013. This amendment was published in the Federal Register (80 FR 70186) on 11/13/2015, and changes the cash deposit rate for the producers/exporters as listed in paragraph
