RE: Amended Cash Deposit Instructions for certain steel nails from the United Arab Emirates produced and exported by Precision Fasteners LLC (A-520-804)

1. On 12/14/2015, Commerce published in the Federal Register the Notice of Court Decision Not in Harmony With Final Determination and Amended Final Determination of the Antidumping Duty Less Than Fair Value Investigation in the antidumping investigation of certain steel nails from the United Arab Emirates (80 FR 77316). The injunction to which message 5022304 dated 01/22/2015, refers, enjoining liquidation of entries which are subject to the antidumping duty order on certain steel nails from the United Arab Emirates for the period 11/03/2011 through 04/30/2013 produced and/or exported by Precision Fasteners LLC remains in effect during the pendency of the period of appeal or until a final and conclusive CAFC decision on any appeals.

2. As a result of the CIT's final decision, Precision Fasteners LLC's cash deposit rate is amended to zero percent. Therefore for shipments of certain steel nails from the United Arab Emirates entered, or withdrawn from warehouse, for consumption on or after 11/13/2015, the effective date of the Court decision, the amended cash deposit requirement is as follows:

Producer and Exporter: Precision Fasteners

Amended rate: 0.00%

3. Instructions for granting a request for a refund on any overcollection or for collecting additional deposits will be issued in a separate message.

4. These cash deposit requirements shall remain in effect until further notice. Do not liquidate any entries covered by the injunction to which message 5022304 refers until specific liquidation instructions are issued.
