1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (77 FR 39467) ON 07/03/2012 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STAINLESS STEEL BAR FROM INDIA FOR THE PERIOD 02/01/2010 THROUGH 01/31/2011.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN COMPANIES.
