RE: Liquidation instructions for citric acid and certain citrate salts from the People's Republic of China for the period 01/01/2013 through 12/31/2013 (C-570-938)

1. Notice of the lifting of suspension of liquidation of entries of subject merchandise occurred with the publication of the final results of administrative review of the countervailing duty order (C-570-938) on citric acid and certain citrate salts from the People's Republic of China for the period 01/01/2013 through 12/31/2013 (80 FR 77318, 12/14/2015).

2. Accordingly, you are now instructed to liquidate all shipments of citric acid and certain citrate salts from the People's Republic of China which were entered, or withdrawn from warehouse, for consumption on or after 01/01/2013 and on or before 12/31/2013 at the following percentage of entered value:

Product: Citric Acid and Certain Citrate Salts

Country: the People's Republic of China

Company name: Laiwu Taihe Biochemistry Co., Ltd.

Case number: C-570-938-005

Final subsidy rate: 30.93%

Laiwu Taihe Biochemistry Co., Ltd. did not have its own case number during the period of review; entries may have been under C-570-938-000 or other company-specific case numbers.

3. There are no injunctions applicable to the entries covered by this instruction.

4. The assessment of countervailing duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated countervailing duties. The interest provisions are not applicable to cash or bonds posted as estimated countervailing duties before the date of publication of the countervailing duty order. Interest shall be calculated from the date of payment of estimated countervailing duties through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such

period.

5. The suspension of liquidation of merchandise entered on or after 01/01/2013 and on or before 12/31/2013 is lifted. Unless instructed otherwise, suspension of liquidation for all entries of merchandise entered after 12/31/2013 will continue.
