1. On 12/31/2015, the U.S. Court of International Trade issued a temporary restraining order (TRO) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on welded carbon steel standard pipe and tube products from Turkey (A-489-501) for the period 05/01/2013 through 04/30/2014. This TRO was issued in connection with court number 15-00338.
2. This TRO enjoins liquidation of entries which were the subject of the administrative determination published as Welded Carbon Steel Standard Pipe and Tube Products from Turkey, 80 Fed. Reg. 76,674 (Dep't Commerce Dec. 10, 2015) (final results of antidumping duty administrative review and final determination of no shipments; 2013-2014); were produced and exported by the following producers or exporters: Borusan Mannesmann Boru Sanayi ve Ticaret A.S., Borusan Istikbal Ticaret T.A.S., Toscelik Profil ve Sac Endustrisi A.S., or Tosyali Dis Ticaret A.S.; and were entered, or withdrawn from warehouse, for consumption on or after May 1, 2013 through and including April 30, 2014.
3. Effective 12/31/2015 (the date the Court issued the TRO), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated as of 12/31/2015 through 5:00 p.m. on 01/08/2016. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Effective immediately, CBP is instructed to follow the terms of the TRO.
5. The TRO applies to the liquidation instructions in message number 5364305, dated 12/30/2015 and message number 5364310, dated 12/30/2015.
