RE: Scope determination on antidumping duty order on seamless carbon and alloy steel standard, line, and pressure pipe from the People's Republic of China (A-570-956)

1. On 02/25/2016, in response to a request by Commercial Honing LLC dba Commercial Fluid Power ("Commercial Honing"), Commerce issued a final scope determination that certain mechanical tubing that Commercial Honing imports and that is manufactured by Jiangsu Huacheng Industry Group Co. LTD is within the scope of the antidumping duty order on seamless carbon and alloy steel standard, line, and pressure pipe from the People's Republic of China ("PRC") (A-570-956). Commercial Honing's mechanical tubing that Commerce found to be subject to the antidumping duty order on seamless carbon and alloy steel standard, line and pressure pipe from the PRC falls under the following product code, S14.000X12.000S.
2. Commerce additionally found that certain other mechanical tubing imported by Commercial Honing is outside the scope of this antidumping duty order and will issue separate instructions regarding that merchandise.
3. Because the imported product described in paragraph 1 above conforms to the dimensional requirements described in the antidumping duty order on seamless carbon and alloy steel standard, line, and pressure pipe from the PRC, Commerce found this product to be within the scope of the order.
4. Continue to suspend liquidation of entries of seamless carbon and alloy steel standard, line, and pressure pipe from the PRC, including product S14.000X12.000S imported by Commercial Honing described above, subject to the antidumping duty order on seamless carbon and alloy steel standard, line, and pressure pipe from the PRC.
