RE: Preliminary injunction on certain steel nails from the PRC for Shandong Oriental Cherry Hardware Group Co., Ltd. for the period 08/01/2013 through 07/31/2014 (A-570-909), court # 16-00059

1. On 04/20/2016, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on certain steel nails from the People's Republic of China (A-570-909) for the period 08/01/2013 through 07/31/2014. This PI was issued in connection with court number 16-00059.

2. This PI enjoins liquidation of entries which:

i. were the subject of the administrative determination published as Certain Steel Nails from the People's Republic of China: Final Results of the Antidumping Duty Administrative Review; 2013-2014, 81 Fed. Reg. 14092 (March 16, 2016);

ii. were entered or withdrawn from warehouse, for consumption, during the period August 1, 2013, through July 31, 2014;

iii. were exported by Shandong Oriental Cherry Hardware Group Co., Ltd.; and

iv. remain unliquidated as of 5:00p.m. Eastern Time on the day on which the Court enters this Order on the docket in this case.

3. Effective 04/20/2016 (the date the Court issued the PI), no liquidation may be made for entries referred to in paragraph 2 which remain unliquidated as of 5:00p.m. Eastern Time on 04/20/2016. Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

4. Effective immediately, CBP is instructed to follow the terms of the PI.

5. Liquidation instructions for entries affected by this PI have not yet been issued.
